



## 2026 Sewer Discharge Permit Rates

City Council has approved a combined 7.32% increase to the water and wastewater/storm rates. The following fees represent the costs associated with Sewer Discharge Permits and are effective January 1, 2026. Only those parameters found in your current permit apply to your company.

## 2026 Sewer Discharge Permit Rates

### Breakdown of fees:

- **Application Fee** - Multiple permit holders pay one application fee per property, per permit (example: if a permit holder requests an Overstrength and Compliance permit, they will pay **\$988.47**).
- **Overstrength Discharge Fees** – Recover the costs to treat wastewater that exceeds the Sewer Use By-law for treatable parameters.
- **Administration Fees** – Recover the costs for the City to monitor a Company's discharge by collecting and analyzing wastewater samples. Multiple permit holders pay the higher administrative fee (for example, if a permit holder has both an Overstrength Discharge Permit and a Compliance Program Permit, they will pay **\$1,203.87** per quarter)
- **Surcharge fees** - Apply to companies that discharge water to the sewer that did not originate and was not purchased from the City of Hamilton's potable water supply.

Example: If a company has purchased 10m<sup>3</sup> of water and discharges 12m<sup>3</sup> into the sewer, there will be surcharge for the extra 2m<sup>3</sup> added to the discharge.

### Requirement of Company to be in good standings:

Please note that any unpaid Sewer Discharge Permit fees to Alectra Utilities (as the City's water/wastewater billing agent), will be transferred to the tax roll for the property if they are past due for 60 days.

The City may suspend or revoke a permit at its option without notice if the Permit Holder fails to pay unpaid accounts and account triggers transfer of unpaid fees to the property's tax roll. The General Manager shall notify the Permit Holder, in writing, 30 days in advance of the proposed action.

### Sewer Use By-law Assessment Report

Have you submitted a Sewer Use By-law Assessment Report for your company? You may be contacted by an Officer in order to ensure our files are accurate and up to date. Once requested by an Officer, you will have **60 days** to submit the Report to our office. A follow-up inspection will be booked to verify the information provided in the Report.
